## 4. First-aid measures

## 5. Fire-fighting measures

Prevent entry into waterways, sewer, basements or confined areas.</p> <p>Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.</p> <p>Never return spills to original containers for re-use.
