## 4. First-aid measures

**Inhalation** If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms develop or persist.

**Skin contact** If clothing sticks to the skin, do not remove. Lotion or hand cream may aid in the removal of asphalt. Wash contact areas with soap and water. If needed, seek medical attention.

**Eye contact** Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention if irritation develops and persists.

**Ingestion** Rinse mouth. DO NOT induce vomiting. Get medical attention immediately. If ingestion of a large amount does occur, call a poison control center immediately.

## 5. Fire-fighting measures

## 6. Accidental release measures

<b>Methods and materials for containment and cleaning up</b>	This product is miscible in water.  Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers. Prevent entry into waterways, sewer, basements or confined areas.  Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.  Never return spills to original containers for re-use. For waste disposal, see section 13 of the SDS. Absorb or cover with dry earth, sand or other non-combustible material and transfer to containers. Ventilate area and avoid breathing vapors or mist. For large spills, dike far ahead of liquid spill for later disposal. Do not release into sewers or waterways.
<b>Environmental precautions</b>	Avoid discharge into drains, water courses or onto the ground.
