Do not release into sewers or waterways. Allow spilled material to solidify and scrape up with shovels into a suitable container for recycle or disposal.

Avoid contact with molten material. Hydrogen sulfide, a very highly toxic gas, may be present with this material. Keep face clear of tank and/or tank car openings. Do not add water to hot product. This may result in frothing of the mixture causing hot asphalt to overflow the container.

Prevent electrostatic charge build-up by using common bonding and grounding techniques. Store in a well-ventilated place. It is recommended that the storage temperature never exceed 375°F.
