**Composition comments** A complex combination of hydrocarbons obtained by treating a petroleum fraction with hydrogen in the presence of a catalyst. It consists of hydrocarbons having carbon numbers predominantly in the range of C20 through C50 and produces finished oil with a viscosity near 200 SUS at 100°F.

## 4. First-aid measures

<b>Inhalation</b>	Move to fresh air. Oxygen or artificial respiration if needed. IF exposed or concerned: Get medical advice/attention.

## 5. Fire-fighting measures

## 6. Accidental release measures

<b>Personal precautions, protective equipment and emergency procedures</b>	Keep unnecessary personnel away. Local authorities should be advised if significant spillages cannot be contained.
