## 5. Fire-fighting measures

<b>Suitable extinguishing media</b>	Halon. Dry chemicals. Foam. Carbon dioxide (CO <sub>2</sub> ). Water spray or fog. Do not use water jet as an extinguisher, as this will spread the fire.

## 6. Accidental release measures

<b>Personal precautions, protective equipment and emergency procedures</b>	Keep unnecessary personnel away. Local authorities should be advised if significant spillages cannot be contained. Wear appropriate protective equipment and clothing during clean-up. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation.
<b>Methods and materials for containment and cleaning up</b>	Large Spills: ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.  Never return spills in original containers for re-use. <b>Environmental precautions</b>	Prevent further leakage or spillage if safe to do so. Prevent entry into waterways, sewer, basements or confined areas. Avoid discharge to the aquatic environment.
