**Composition comments** A complex combination of hydrocarbons obtained by removal of normal paraffins from a petroleum fraction by solvent crystallization. It consists of hydrocarbons having carbon numbers predominantly in the range of C20 through C50. It produces finished oil with a viscosity near 150 SUS @ 100°F (29 cSt @ 40°C).

### 4. First-aid measures

**Inhalation** Move to fresh air. Oxygen or artificial respiration if needed. IF exposed or concerned: Get medical advice/attention.
